O R D E R

By our judgment dated 15.12.2017, we had, in paragraph Nos. 32 and 37, made it clear that insofar as drugs that have been banned and which were manufactured pre 21st September, 1988, (the 15 drugs in question covered by the Central Government notifications banning them) was set aside.

We had made it clear that the Central Government may *de novo* carry out an inquiry as to whether such drugs should be the subject matter of a fresh notification under Section 26A of the Drugs Act.

This being the case, we dispose of the present miscellaneous applications in terms of our interim order dated 31.08.2018.

We have since been informed that on the date we made the interim order dated 31.08.2018, the Sub-Committee has already forwarded a report with regard to 15 drugs as aforesaid. The Government will act upon the said report save and except with regard to the aforesaid 15 drugs.

Miscellaneous applications stand disposed of accordingly.
